

CALUMET TOWNSHIP INDOOR RANGE – RANGE RULES

1. The NRA Three Basic Rules of Gun Safety are the foundation of firearms safety on this range. These rules are:
 - a. ALWAYS Keep The Gun Pointed In A Safe Direction
 - b. ALWAYS Keep Your Finger Off The Trigger Until Ready To Shoot
 - c. ALWAYS Keep The Gun Unloaded Until Ready To Use
2. Range users shall comply with all Federal, State of Michigan, and Houghton County firearms laws
3. NO concealed carry or open carry of firearms on premises during range hours.
Exception: Law enforcement officers.
4. Until directed by the Range Safety Officer (RSO), ALL firearms must remain unloaded and cased. Firearms will be placed on designated tables in the firing range. NO firearms are allowed to remain in the break room/boiler room or other areas for any reason.
5. All commands issued by the RSO must be obeyed immediately. Failure to do so may result in removal from the range and loss of range privileges.
6. No ammunition is allowed in a designated Safety Area. Users may uncase an unloaded firearm, perform basic maintenance on an unloaded firearm, or uncase and holster an unloaded handgun in the designated Safety Area to rear of range, facing left range wall. No firearms will be handled anywhere outside the actual firing range room.
7. ANSI-approved eye and ear protection must be properly worn by all persons present in the firing range while the range is in a hot status.
8. Firearms shall be standard handgun calibers only, not to exceed 2000 fps and 850 ft-lbs energy (.44 Special). Only lead, plated/coated lead, copper-jacketed and commercial defensive/frangible ammunition may be used. All other types of ammunition and projectiles are prohibited.
9. Only paper or cardboard targets may be used.
10. Targets will be aligned so that the bullet's path places the impact well within the impact plate, not on the lower deflector plate, the floor, side walls, or ceiling. Shooting anything other than your intended target and the impact plate may result in your removal from the range.
11. Township-approved competitions held on the Range shall be conducted in accordance with official published rules of the sanctioning body of the match, and subject to the rules set forth herein and in the SOP.

**WHEN IN DOUBT, ASK A RANGE SAFETY OFFICER!
FAILURE TO ABIDE BY THESE RULES MAY RESULT IN A TEMPORARY OR PERMANENT
REMOVAL FROM THE RANGE.**

CALUMET TOWNSHIP INDOOR RANGE – PROHIBITED ITEMS

1. Fully automatic firearms or firearms operating in “burst” mode are prohibited.
2. **Steel shot, armor piercing, tracer rounds and steel core bullets are prohibited.**
3. BB guns are prohibited.
4. Children under the age of 9 years old are not allowed in the range areas for any reason.
5. Coats, book bags, backpacks, and similar items are prohibited in the actual firing range. Only shooting bags and firearm cases are allowed in the actual range.
6. Any person under the influence of alcohol, drugs or any substance that might impair judgement or coordination is prohibited from entering the range building.
7. Use or storage of Black Powder is prohibited in the range areas.
