This permit is in the issuance process. Public notice will end on 2-15-24, at wich point the project will go out to bid with a bid opening 4 weeks from that time. Bjorn informed the board the Jeff West is working with NHCWSA's Attorney on final certification or ROW and easements. Bjorn presented a legal services agreement, audit agreements for 2023, 2024, and 2025 with Susan Sanford, and an invoice in the amount of 18,504.58 for work completed to date by UPEA.
